AN ORDINANCE TO AMEND CHAPTER 72

SCHEDULE I CONCERNING STOP INTERSECTIONS
WHEREAS, the Town Council of Milan, Indiana, has previously adopted Ordinances creating stop intersections, and

WHEREAS, the Town Council desires add a stop sign to Main Street on the Northbound side at Carr Street.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF MILAN, INDIANA:

Section 1. That Chapter 72, Schedule I of the Town Code of Ordinances be amended by adding the following stop intersection:

ORDINANCE

CLARIFYING §90.007 LITTERING

WHEREAS, the Town Council of the Town of Milan, Indiana, finds that clarification of Ordinance §90.007 - Littering is necessary to specify that leaves, twigs, weeds, yard clippings, landscape clippings, and like materials are considered litter under the existing ordinance; and

WHEREAS, this clarification is necessary as yard refuse that is blown or otherwise deposited into the street may clog the Town's storm water drain system which can cause back up and flooding to homes and property.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF MILAN, INDIANA, THAT §90.007 IS CLARIFIED AND AMENDED AS FOLLOWS:

“§90.007 LITTERING PROHIBITED.

No person shall throw or place, deposit, or blow any rubbish, litter or any refuse matter or any foreign matter of any kind in any street, sidewalk, alley or public place in the town. This includes any yard waste, leaves, twigs, weeds, yard clippings, landscape clippings, yard refuse or like materials. No person shall haul on any street or alley any rubbish, ashes, earth, sand, stone or other material liable to become scattered on the streets, except in a vehicle provided with a closed or open box well closed on the side so as to retain the materials. No person shall scatter any materials from any vehicle upon any street or alley.

Penalty, see §90.999”

Section 3: This Ordinance shall be in effect after publication. Primarily adopted by the Council of the Town of Milan, this 13th day of May, 2019.
