# B'ville has opportunity for downtown redevelopment

The City of Batesville is on the cusp of a tremendous opportunity for redevelopment in their beautiful downtown.

pleased to share that Lisa has entered into

purchase two downtown buildings previously owned by Baxter (this includes the property previously known as the HillRom Training Center and the property previously known as the AP Building), as well as The Sherman, Biergarten, and Bier Hall Event Factory. While Lisa is planning to move her current Cosawove operations from their existing location and into this space, she also has a much grander vision for the properties which will benefit many more residents of Batesville and the surrounding area.
