Property owners, ratepayers and other interested parties in or served or to be served by the Gas Utility of the Town of Osgood, Indiana ("Town") are hereby notified that a public hearing will be held by the Town Council of the Town, at the Osgood Town Hall, 147 West Ripley Street, Osgood, Indiana 47037, commencing at 7:00 P.M. on May 20, 2025. The purpose of the hearing is to consider an increase in minimum charges for meters, reconnection fees, and other miscellaneous fees

At the hearing, interested persons may be heard the concerning proposed increases. The proposed ordinance sets rates and makes such amended rates and charges effective for June 2025 usage and billing. The complete text of the proposed ordinance is available for examination and copying at the office of the Clerk-Treasurer at the Town Hall

MINIMUM CHARGES (A) Each customer shall pay a minimum monthly gas meter charge per meter in accordance with the type of

meter installed, to-wit: (1) Residential (R-275 meters): \$10 per month;

(2) Small commercial (415 to 900 series meters): \$25 per month; and

(3) Medium and large commercial and industrial (rotary meters): \$40 per (B) In addition, there will be a \$600 service reconnection

charge for reconnection of service meters, which shall be paid prior to meter reconnection ...

(N) A commercial customer (i.e. industry, manufacturing, business, farming, etc.) requiring an upgrade to its gas meter shall pay the actual expense to the town for the upgraded equipment. The town thereafter may maintain the upgraded equipment.

additional  $(\mathbf{O})$ Any expenses incurred by the town as a result of an emergency may be billed to the customer.

(P) Any customer approved for a connection / tap must be connected to the utility within 30 days of approval. Failure to do so may result in additional fees.

All other rates and charges of the Osgood Gas Utility will remain unchanged.

Batesville softball ran into a pair of offensive juggernauts last week in Eastern Indiana Athletic Conference action, falling to Franklin County and Greensburg in a pair of home games.

The Lady Bulldogs lost 30-2 to the Lady Wildcats on Thursday before an 11-0 loss to Greensburg one night later. Batesville has now lost three-straight games after starting 2-1 on the season.

After a 1-1 score through one inning, Franklin County (6-3, 1-2 EIAC) erupted for 14 runs in the top of the second and followed with 10 runs in the top of the third inning. The assault ended with five runs in the top of the fourth and Batesville added one final score just prior to the game ending with the mercy rule in effect.

Franklin County connected for 29 hits and Bailey Kaiser went a perfect 5-for-5 while hitting for the cycle. In addition to a pair of singles, a double, triple and home run, she also drove in five runs and scored four times. Brooke Stang was 4-for-6 with a double, eight RBI and four runs.

Cora Roth had the only hit for Batesville and added a run scored. Caitlyn Fox scored the other Lady Bulldog run. The duo combined out four and allowing only one hit in two innings.

Batesville was again held to just one hit on Friday night in the loss against Greensburg (5-1, 1-0 EIAC). The Lady Pirates piled on six runs in the first two innings and never looked back. eventually ending the game after five innings which included three final runs in the top of the fifth. Fox had the only hit for the Lady Bulldogs and also had three stolen bases.

Stephens again was forced to take a pitching loss, allowing eight earned runs on nine hits with three walks.

In the wake of recent storms and flooding across Indiana, Attorney General Todd Rokita is calling on all Hoosiers to remain vigilant as scammers look to exploit these disasters by targeting charitable and helpful individuals. Just as fraudsters prey on generosity during holiday seasons, they also take advantage of those seeking assistance or repairs after severe weather. Attorney General Rokita says Hoosiers should take proactive steps to protect themselves from deceptive schemes promising aid or services.

"Hoosiers are good-hearted people who may want to donate to help quickly rebuild hard hit communities after the recent devastating storms, but that giving nature can make them targets for scammers looking to profit from hardship," Attorney General Todd Rokita said. "We must stay one step ahead of these fraudsters by doing our homework and ensuring our resources go to legitimate recovery efforts, not into the hands of con artists."

Attorney General Rokita says his office is committed to tracking down and bringing to justice the criminals who perpetrate illegal scams while also empowering Hoosiers to avoid becoming victims.

With communities across the state facing significant damage from recent storms and flooding, Attorney General Rokita offers the following tips to safeguard against charityrelated scams:

• Slow Down: A real charity will accept your donations any day of the week. Take as much time as you need to feel confident that your money is being used to help the cause you expect. Ask questions. If the request for a donation is over the phone, the caller should be able to answer critical questions.

· Make sure you are dealing with the real charitable organization. Be leery of unknown or unfamiliar organizations you receive by phone, mail, email, and/or social media.

 Always donate by credit card rather than cash or other methods. This will ensure you can access the protections available through your credit card company.

• Research the cause or the organization: Search online for the name of the organization or cause with words like "review," "scam," or "complaint." See if others have had good or bad experiences with the charity. Check out what charity watchdog groups like CharityNavigator.org, CharityWatch. org, Give.org, and Guidestar.org say about that organization.
