Indiana Drives Change to Protect Older Foster Youth Through New Laws

Indiana has long been a leader in supporting older foster youth, and two new laws that took effect on July 1 2025, were to ensure that we continue to support teens and young adults experiencing foster care. These measures help ensure these young Hoosiers

have the support they need to pursue their education employment goals. With unanimous support, the Indiana General Assembly passed two bills (HEA 1099 and HEA 1441) this past session that will help more young people build stable, financial futures.

HEA 1099 expands the eligibility of the Insuring Foster Youth Trust Fund to support more young people who have spent time in foster care so that they can have assistance meeting the requirements to get their driver's license and access affordable auto insurance.

HEA 1441 breaks down barriers that many teens in foster care have experienced - accessing safe and secure bank accounts to hold their money. Under HEA 1441, with judicial consent, 16 and 17-year-olds experiencing foster

care will be able to open a checking or savings account without an co-signer. adult In the past, it was incredibly difficult for teenage foster vouth to open a bank account to keep their money safe. State Repre-

Campbell (D-West Lafayette) introduced the banking legislation after hearing from a constituent the challenges that he faced when his foster parents had access to his bank account as a minor and the continued challenges he had in removing his foster parents from the account after he turned 18. That constituent, a Foster Success program participant, told lawmakers the changes included in the new law will provide extra security for foster youth.

Sadly, that story is not uncommon for these older foster youth who often don't have a consistent, trusted

adult in their lives. The difficulty involved in opening a bank account leads them to avoid banking and choosing less secure and more costly ways handle their money such as apps that are not associated with an FDIC insured institution. Sadly, some resort to keeping hundreds of dollars in cash in a shoe box under their bed while others are forced to choose more expensive options that are less convenient such as check cashing ser-

vices. These may not have been the flashiest laws to come out of this year's legislative session, but they have the ability to make a dramatic difference in the lives of thousands of teens and young adults as they save and prepare for self-sufficient lives outside of our state's foster care system.
